**The following are required application materials:**

1. The signed completed application form.
2. Submit a transcript of your high school grades.  
Must include ACT/SAT scores if the college you will be attending requires them.  
Ex. 4 Year College or University requires ACT/SAT scores
3. Recommendations from two academic teachers who have had the student in class within the past eighteen months. The recommendation form should be completed by the academic teachers and sent directly to the cooperative. *It is the student's responsibility to make sure that the references have been submitted by the due date.* You may wish to ask more than two teachers to complete the form.
4. One page essay describing your character, community involvement and why you should receive this scholarship. All applications can be dropped off at our office, emailed to [sgroebner@redwoodelectric.com](mailto:sgroebner@redwoodelectric.com) or they can be mailed to:

**A scholarship will be granted to individuals who will graduate from area high schools and plan to continue their education by attending college, vocational school or trade school. Applications will be accepted from individuals whose parent or guardian is a Redwood County Cooperative member.**

1. Applicants must be a student whose parent or guardian is a Redwood County Cooperative member.
2. Applicants must be a high school senior at the time of application.
3. Student can only receive the scholarship once.
4. The application deadline will be March 8th, 2019. All required documentation must be in our office NO LATER than 3:30 pm on March 8th.
5. The scholarship winners will be announced before April 4th, at our Annual Meeting, and in our Power Lines newsletter. You will also receive a letter in the mail if you have been selected as one of the scholarship recipients.
6. The Redwood Electric Trust Board will review applications and select the scholarship recipients. Incomplete applications will not be considered.
